Acht na dTeangacha Oifigiúla 2003

Dréachtscéim á réiteach ag an mBord um Chúnamh Dlíthiúil

Tá an dara scéim dá chuid á réiteach ag an mBord um Chúnamh Dlíthiúil de réir Alt 11 d'Acht na dTeangacha Oifigiúla 2003. Is é príomhchuspóir an Acharta a chinntí go mbeidh fáil níos fearr ar sheirbhísí poiblí trí Ghaeilge agus go mbeidh siad ar chaighdeán níos airde. Beartaítear go mbeidh an dara scéim i bhfeidhm ar feadh tréimhse trí bliana ar éag don scéim reatha.

Is mian leis an mBord um Chúnamh Dlíthiúil anois cuireadh a thabhairt d'aon pháirtí leasmhar uirfolla a dhéanamh maidir le réiteach na scéime nuá. Preparation of a Draft Scheme by the Legal Aid Board

The Legal Aid Board is preparing its second scheme in accordance with Section 11 of the Official Languages Act 2003. The primary objective of the Act is to ensure better availability and a higher standard of public services through Irish. It is proposed that the second scheme will run for three years from the expiration of the current scheme.

The Legal Aid Board now wishes to invite representations in relation to the preparation of the new scheme from any interested parties. Submissions should not exceed 4,000 words and should take account of the previous scheme (available on the Board's website). Submissions, which will be published on the Board's website, should be forwarded electronically to eolas@legalaidboard.ie.
